Our heating system plans include a multi-point inspection upon sign up which includes a CO report. Additional maintenance above and beyond the regular scope of included maintenance may be required at the discretion of Crystal Heating if the equipment has not been regularly maintained.

Appliances not eligible for coverage: commercial products, heat pumps, ductless splits, wall furnaces, space heaters and conversion burners.

Items not covered by your plan: heat exchanger cleaning or replacement, heating coils (air handlers) cleaning or replacement, combustion chambers, boiler heating sections and accessories, heating system accessories (humidifiers, filters, UV cleaners, etc.), air conditioning components, high voltage wiring or fuses, nuisance calls at our discretion such as; improper thermostat setting or dead batteries, plugged filters, etc.
