# HOME RENOVATION SAVINGS PROGRAM

- · Complete a minimum of 2 upgrades
- Qualify': Enbridge Gas customers who primarily heat their home with natural gas OR electrically heated homes connected to the Ontario electricity grid
- Maximum Rebate (total): \$5,000 for Enbridge Gas, \$10,000 for electrically heated homes
- Deadline: Final assessment must be completed within 180 days of first assessment
- **Eligible:** Detached, semi-detached, row and mobile homes on permanent foundation

# Home Renovation Savings Assessment\* Stream Upgrades:

Do two or more upgrades. You **must complete the energy assessment** prior to installing any upgrades.

\*\$600 assessment fee rebate, only paid once per premises for duration of this program.

# Windows, Doors, Skylights and Sliding Doors:

Each window, door, skylight or sliding door replaced with an ENERGY STAR certified model (Minimum of 3 windows or 1 door or 1 skylight or 1 sliding door replaced with ENERGY STAR certified models required)
Rebate Amount: \$100 per rough opening

# Attic3:

Minimum 50% of the total roof assembly. The grant amount will be prorated based on the percentage of your attic that you choose to insulate. For example, if you insulate 80% of your attic you would qualify for 80% of the amount listed to the right.

# Cathedral Ceiling/Flat Roof<sup>3</sup>:

Minimum 50% of the total roof assembly.

Less than or equal to R-12	R-20	\$780
Less than or equal to R-25	R-28	\$780

# HRS - Heat Pump Stream:

Incentives available for cold climate air source heat pumps and ground source heat pumps listed on NRCan's qualified product list (centrally ducted, partially ducted, and ductless).

- The contractor will facilitate the rebate process for the customer.
- Heat pump must be installed by a participating heat pump contractor.
  - » Contractors must complete a registration process to be added to the program.

# To qualify for a heat pump rebate, you must:

- Own the home where the heat pump will be installed. Where an owner has tenants, the owner must apply.
- Be an Enbridge Gas customer with an active account and primarily heat your home with a natural gas furnace or boiler OR be connected to the Ontario electricity grid and heat your home electrically.
- Live in a single detached, semi-detached, row house, townhome, or mobilehome on a permanent foundation.
  - » New build homes do not qualify. The home must have achieved at least 6 months of occupancy to become eligible

#### More than One Roof Assembly Example:

Rebate pro-rated based on % complete. 50% minimum.

#### Attic:

· Level of Insulation at the time of Pre-Audit:

#### Greater than R-12 to R-25

- · Minimum Insulation Level to Reach by Post-Audit: R-50
- · % Area Insulated: 60%
- Max Rebate: \$720 (60% of \$1,200) Max Rebate: \$312 (40% of \$780)

#### Cathedral Ceiling:

- · Level of Insulation at the time of Pre-Audit: Less than or equal
- Minimum Insulation Level to Reach by Post-Audit: R-28
- % Area Insulated: 40%

#### Exterior Wall: Rebate pro-rated based on % complete. 20% minimum.

For a semi-detached or end unit row house, you will not qualify for the full amount of the grant; the maximum you would be eligible for is 75% of the listed amounts. For a middle unit row house, you will not qualify for the full amount of the grant; the maximum grant amount you would qualify for is 50% of the listed amounts.

#### Level of Insulation Added between the Pre and Post Audit:

R-7.5 to R-12 Max Rebate: \$1,200 Greater than R-12 to R-20 Max Rebate: \$2,100

Greater than R-20 Max Rebate: \$3,600

Foundation Header\*: Insulate at least At least 80% of your entire foundation header area to increase the insulation value to add a minimum of R-20. Rebate Amount: \$300

Basement Slab: Insulate at least 50% of your entire basement slab by a minimum of R-3.5. Rebate Amount: \$500

### Basement Wall: Min 20% of the area required to qualify.

If insulating both crawlspace walls and basement walls, max rebates for both combined cannot exceed \$1,500.

#### Level of Insulation Added between the Pre and Post Audit:

R-10 to R-22 Max Rebate: \$900 Greater than R-22 Max Rebate: \$1,500

# Exterior Crawl Space Wall: Min 20% of the area required to qualify.

If insulating both crawlspace walls and basement walls, max rebates for both combined cannot exceed \$1,500.

#### Level of Insulation Added between the Pre and Post Audit:

R-10 to R-22 Max Rebate: \$600

Greater than R-22 Max Rebate: \$1,200

### Crawl Space Ceiling: Insulate 100% of ceiling above Crawl space.

Level of Insulation Added between the Pre Max Rebate: \$1,200 and Post Audit: Greater than R-24

# Exposed Floor: Minimum 120 sqft of area required.

Level of insulation added: Minimum of R-20 Rebate Amount: \$300 to the entire exposed floor area

#### Air Sealing:

Achieve the Base Target on your Renovation Rebate Amount: \$200 Upgrade Report Achieve 10% or more above the Base Target Rebate Amount: \$250

on your Renovation Upgrade Report

# Heat Pump Water Heaters: Must be on eligible products list.

Replace your natural gas or electric domestic hot water heater with an ENERGY STAR certified Domestic Heat Pump Water Heater (HPWH) ENERGY STAR technical specifications.

Rebate Amount: \$500

### HRS - Solar/Battery Stream:

- Incentives for the purchase and installation of an eligible solar PV system (rooftop only) and battery storage system, when paired with solar PV.
- Pre-installation approval and post-installation approval steps
- Must complete all applicable applications and permits from the local municipality, LDC, and regulatory bodies as required.
- This will include submitting a Micro Embedded Generation Application, or equivalent with the LDC, submitting a signed connection agreement, and passing ESA and LDC final inspections upon final installation and commissioning of the DER system.
- · New solar and storage installations only, no expansions of existing systems



#### Solar PV Panels:

Incentives of \$1,000/kW up to \$5,000, limited to 50% of project costs.



#### Battery Storage5:

Incentives of \$300/kWh up to \$5,000, limited to 50% of project costs 5.

#### HRS – Smart Thermostat Stream:

The Smart Thermostat stream offers eligible customers a \$75 rebate on the purchase of a qualified smart thermostat model.

- · Participants must not have previously received a smart thermostat rebate, discount, or device from Enbridge Gas, Save on Energy, or the Home Renovation Savings program.
- Homes must be single/semi-detached, row/townhome, or mobile home on a permanent foundation.

#### How to get your rebates:

Customers can choose either option but not both.

- 3. Receive \$75 discount code

# Save After You Buy:

- 1. Purchase qualifying smart thermostat from any
- 2. Submit application and invoice online within 60 days of purchase
- 3. Enbridge Gas customers receive the \$75 rebate as a bill credit, electric customers receive a cheque
